## **Absher Commits to Sustainable Construction Leadership**

September 19, 2022—Absher recently joined 20 general contractors in the United States in signing the “Contractor’s Commitment to Sustainable Building Practices,” created by BuildingGreen’s Sustainable Construction Leadership (<https://www.buildinggreen.com/contractors-commitment>). The Contractor’s Commitment provides a sustainability framework with benchmarks specific to the construction industry, providing uniformity in reporting performance in five areas—Carbon Reduction, Jobsite Wellness, Waste Management, Water Management and Materials—across 30% of a general contractor’s projects, by dollar volume. In signing the commitment, Absher will:

- Measure and benchmark greenhouse gas emissions at their corporate offices and project sites.
- Work closely with their small-, minority-owned, women-owned, veteran-owned, and disadvantaged business project partners to support their own sustainability journey and reduction of their carbon footprint.
- Support preconstruction methods that reduce embodied carbon and use of healthier materials as well as methods that reduce waste generation, such as deconstruction and material reuse.
- Implement decarbonization strategies through new business practices, including efficiency improvements, innovative commute trip reduction, fleet and equipment electrification, procurement processes and other carbon-emission elimination strategies.

In 2022, Absher began to track their corporate emission impacts and became recognized as an EnviroStars Green Business. In 2023, the firm will begin tracking Scope 3 emissions and continuing improvements to their sustainability roadmap, utilizing the guidance of the Contractors Commitment.

In the last 5 years, more than 50% of Absher’s projects featured green building systems and certifications. Executing construction in a sustainable manner that reduces the project’s carbon footprint, diverts waste from landfills and supports healthy building environments is a critical component of these initiatives.
